- Pt. declined NG

**10 Dec 2022 R/v:**

- Masseter tenderness & occlusal wear-no major changes
- New complaint: loud snoring, excessive daytime sleepiness
  - Plan-Referral for sleep studies
  - Dx: Obstructive sleep apnea (OSA)
  - Tx: Continuous Positive Airway Pressure (CPAP) & regular monitoring

**TODAY**

Pt c/o ↑ jaw soreness & sensitivity

**Examination:**

- Gen attritn - Max & Man molars
- Masseter muscle tender on palpation
- Class I occlusion

**Discussion:**

- Untreated bruxism → serious dental & overall health issues(for ex. sleep disruptions)
- Pt.agreed NG therapy

**Plan:**

- Adv given: Warm compress over jaw muscles, jaw exercises & OTC ibuprofen (400 mg, 6–8 hours) for pain & inflammation
- Counselling done-smoking cessation
- Ref to prosthodontist for further assessment, occlusal evaluation, and fabrication of NG
